

ORDINANCE NO. 26-02

AN ORDINANCE PROVIDING FOR THE LEVY, ASSESSMENT AND COLLECTION OF TAXES FOR THE FISCAL YEAR BEGINNING JULY 1, 2025 AND ENDING JUNE 30, 2026.

WHEREAS, the Board of Library Trustees of the Four Star Public Library District in the County of Adams and the State of Illinois, did on the 10th day of September, AD 2025, pass the annual appropriation bill for said Four Star Public Library District for the fiscal year beginning on the 1st day of July, 2025, the amount of which is ascertained to be the aggregate sum of \$294,941.88 which said appropriation bill was duly published on the 17th day of September, AD 2025.

BE IT ORDAINED by the President and Board of Library Trustees of the Four Star Public Library District, County of Adams and State of Illinois.


SECTION 1. The following sums, or so much thereof as may be authorized by law, being the total amount of all appropriations for corporate purposes legally made and to be collected from the tax levy of the current fiscal year beginning July 1, 2025, and ending June 30, 2026, shall be and the same hereby assessed and levied upon and against all real and personal property within the limits of the Four Star Public Library District, Counties of Adams and Hancock, and State of Illinois, subject to taxation as the same is assessed for State and County purposes for the current fiscal year.

SECTION 2. The purposes for which said levy is made and the sum or sums appropriated for said purposes as shown by the Appropriation Ordinance, adopted September 10th, 2025, which by references thereto is made a part hereof, as if fully set out, herein, respectively are as follows, to-wit:


SECTION 3. The Secretary of the Board of the Library Trustees shall file a certified copy of this Ordinance with the County Clerk of the County of Adams and Hancock and State of Illinois as provided by law so that the tax may be by him extended on the Collector's books for said year, agreeable to the statute in such cases made and provided.

SECTION 4. This ordinance shall be in full force and effect from and after its passage and approval.


