

ORDINANCE NO. 27-01

COMBINED ANNUAL BUDGET
AND APPROPRIATION ORDINANCE
OF THE FOUR STAR PUBLIC LIBRARY DISTRICT
FOR THE FISCAL YEAR COMMENCING
JULY 1, 2026 AND CLOSING JUNE 30, 2027

WHEREAS, the Board of Library Trustees of the Four Star Public Library District, Adams County, Illinois, has prepared or caused to be prepared an Annual Budget and Appropriation for said Library District for the fiscal year beginning July 1, 2026 and ending June 30, 2027 and the same has been conveniently available for public inspection for at least (30) days prior to final action thereon; and

WHEREAS, a public hearing was held as to such Annual Budget and Appropriation Ordinance on September 9, 2026, notice of which was given at least thirty (30) days prior thereto; and

WHEREAS, all other legal requirements have been duly complied with by the Board of Trustees of the Four Star Public Library District;

NOW, THEREFORE, BE IT ORDAINED BY THE PRESIDENT AND BOARD OF TRUSTEES OF THE FOUR STAR PUBLIC LIBRARY DISTRICT, IN THE COUNTY OF ADAMS AND STATE OF ILLINOIS, AS FOLLOWS:

Section 1: That the following sums, or so much thereof as by law may be authorized, be and the same are hereby budgeted, set aside and appropriated for the specified Library Purposes for the fiscal year beginning July 1, 2026 and ending June 30, 2027; and the objects and purposes for which said appropriations are made, and the amounts thereby appropriated are as follows; to-wit:

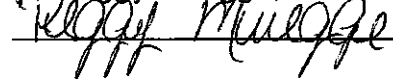
Section 3: The Secretary of the Four Star Public Library District is hereby authorized and directed to have this Ordinance published at least once in a newspaper of general circulation within this library district.

Passed by the Board of Trustees of the Four Star Public Library District and approved by the President thereof this 9TH day of September, 2026.

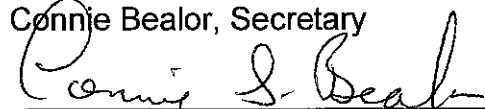

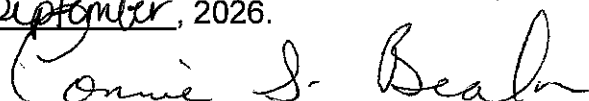
